### The school is directed to ensure that :

- The total number of section of the school after upgradation, shall be restricted to 33 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
- 1. The total number of section of the school shall be restricted to 33, of which not more than 1/3rd sections may be used for senior secondary classes and number of the students are restricted to 32 in 24 classrooms (as the dimension of 24 Classrooms is Between 400 To 500 Sq Ft). Further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of rooms>500 ft.
- 2. The school has submitted a work order in r/o of modular furniture for science labs issued by executive engineer of Haryana police housing corporation dated 14-03-2023. Thus, the school is required to upgrade all the labs as per the Board's SoPs (https://saras.cbse.gov.in/SARAS/Circulars/Circular11\_2022.pdf and submit the compliance within 03 months.
  - 3. The school shall conduct training of its teachers with CoE Panchkula within 3 months and submit the compliance.
- 4. The school shall not remove the videography links from the mandatory disclosure section of its website and renew all mandatory certificates from time to time
  - 5. The school shall follow the SoPs of the Board for its labs, library and sports facilities.

All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
